This ticket is purchased from Mt Hotham Skiing Company Pty Ltd or Falls Creek Ski Lifts Pty Ltd (Hotham/Falls) for use in the Mt Hotham Alpine Resort and/or the Falls Creek Alpine Resort subject to the following conditions:

1. Hotham/Falls, its employees and agents (the supplier) shall have no liability whatsoever in negligence, breach of contract or statute or statutory duty (including conditions or warranties implied by Section 74 of the **Trade Practices Act 1974**) to the Ticket Purchaser or User (the Customer), their Dependant/s or legal representative for personal injury or death suffered by the Customer arising in any way whatsoever from the supply of recreational services, including but not limited to, skiing, snowboarding, snow tubing, tobogganing, skiing or snowboarding lessons, the use of ski lifts, all ski area services, facilities, helicopter flights between Resorts, the conditions, layout or design of ski runs or slopes or the presence of people or objects thereon or any associated sporting activities or similar leisure time pursuits.
2. The Customer acknowledges that these activities are dangerous with many inherent risks as a result of which personal injury (and sometimes death) are common and ordinary consequences and assumes and accepts all risk of personal injury or death in any way whatsoever arising from such activities.
3. **WARNING:** If you (the Customer) participate in these activities you will give up your rights to sue the supplier under the **Fair Trading Act 1999** if you are killed or injured because the activities were not supplied with due care and skill or were not reasonably fit for their purpose.  
**NOTE:** This waiver of rights to sue does not apply if your death or injury is due to recklessness or gross negligence on the part of the supplier.
4. This ticket must be worn on the upper part of the body and be clearly visible. It remains the property of Hotham/Falls is not transferable and cannot be resold. ### ADDITIONAL SEASON PASS TERMS & CONDITIONS

1. All pass holders must sign & agree to the Terms & Conditions prior to obtaining their pass.
2. Season 6 pass holders are not permitted to use the lifts on Saturdays, including night skiing.
3. Season Pass and Season 6 Pass purchases are non-refundable and non-transferable once payment has been processed. ( Subject to payment and conditions of the refundable pass option)
4. Passes are valid for use at Mount Hotham and Falls Creek Resorts.
5. Proof of identification will be required for collection of your pass.
6. Names on the Season Pass and Season 6 Pass orders cannot be altered after the order has been made.

### LOST OR STOLEN PASSES

Season Pass and Season 6 Pass holders should note that if their pass is lost, stolen or destroyed they should;

1. Report it to the Police and retain a copy of the police report
2. Complete a lost or stolen pass form from Hotham Central Ticket Office. The pass holder will need to hand in both forms to Hotham Central Ticket Office, if MHSC is satisfied that the pass has been lost or destroyed it will re-issue it after 48 hours along with a payment fee of \$35 to be paid at the time of collection.
