This ticket is purchased from Mt Hotham Skiing Company Pty Ltd or Falls Creek Ski Lifts Pty Ltd (Hotham/Falls) for use in the Mt Hotham Alpine Resort and/or the Falls Creek Alpine Resort subject to the following conditions:

IMPORTANT NOTICE

EXCLUSION OF LIABILITY – YOUR ASSUMPTION OF RISK - THESE CONDITIONS AFFECT YOUR LEGAL RIGHTS!

WARNING: If you participate in the Recreational Activities detailed below your rights to sue the supplier under the **Fair Trading Act 1999**, if you are killed or injured because the activities were not supplied with due care and skill or were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in or on this notice.

NOTE: The change to your rights, as set out in or on this sign, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the **Fair Trading (Recreational Services) Regulations 2004**.

Mt Hotham Skiing Company Pty Ltd and Falls Creek Ski Lifts Pty Ltd, as the respective supplier of Recreational Services, sell all tickets and supply all recreational ski area services and facilities including, but not limited to skiing, snowboarding, snowtubing, tobogganing, skiing or snowboarding lessons, the use of ski lifts and helicopter flights between Mt Hotham Alpine Resort and Falls Creek Alpine Resort ("Resorts") ("Recreational Activities") subject to the following conditions:

1. These conditions do not affect any rights you have under Schedule 2 of the **Competition and Consumer Act 2010 (Cth)** ("the Act") except to the extent excluded in condition 2.
2. We and our employees, directors, officers, guides, instructors, contractors and agents ("the supplier") are not liable to you, your dependants or legal representatives in negligence, breach of contract or statute or statutory duty (including for breach of consumer guarantees implied by the Act) for personal injury or death suffered by you from our supply of Recreational Activities and the condition, layout, construction, design or use of ski runs or slopes or the presence of people or objects or any associated sporting activities or similar leisure time pursuits on or at the Resorts.
3. You acknowledge that the Recreational Activities are dangerous with many inherent risks, dangers and hazards and personal injury and sometimes death can occur and you assume and accept all risk of personal injury or death from Recreational Activities, and you waive the right to sue the supplier for any personal injury or death in any way whatsoever arising from such activities.
4. You must:
 - (a) wear your ticket on the upper part of your body so it is clearly visible; and
 - (b) not transfer or resell it.
5. Your ticket is only valid for the date shown on it and if the seal is not broken.
6. We will not refund or replace a ticket:
 - (a) if you lose it or suffer an illness or injury;
 - (b) if any lift service is not operating.

You must comply with the **Alpine Responsibility Code** and our signs or other directions and we may suspend or cancel your access to Recreational Activities at our absolute discretion for non compliance with these conditions, the Alpine Responsibility Code or for reckless or careless conduct.

ADDITIONAL SEASON PASS TERMS & CONDITIONS

1. All pass holders must sign & agree to the Terms & Conditions prior to obtaining their pass.
2. Season 6 pass holders are not permitted to use the lifts on Saturdays, including night skiing.
3. Season Pass and Season 6 Pass purchases are non-refundable and non-transferable once payment has been processed. (Subject to payment and conditions of the refundable pass option)
4. Passes are valid for use at Mount Hotham and Falls Creek Resorts.
5. Proof of identification will be required for collection of your pass.
6. Names on the Season Pass and Season 6 Pass orders cannot be altered after the order has been made.

LOST OR STOLEN PASSES

Season Pass and Season 6 Pass holders should note that if their pass is lost, stolen or destroyed they should;

1. Report it to the Police and retain a copy of the police report
2. Complete a lost or stolen pass form from Hotham Central Ticket Office. The pass holder will need to hand in both forms to Hotham Central Ticket Office, if MHSC is satisfied that the pass has been lost or destroyed it will re-issue it after 48 hours along with a payment fee of \$35 to be paid at the time of collection.

ADDITIONAL TERMS & CONDITIONS FOR THE SUPER PASS

A Super Pass is subject to the above terms and conditions and the terms and conditions below:

1. One day lift tickets issued to Super Pass holders are non-refundable and non-transferable.
2. Hotham and Falls Creek Super Pass holders are not entitled to any discounts or privileges made available

- to Perisher Super Pass holders at Perisher other than lift ticket benefits.
3. Perisher Super Pass holders are not entitled to any discounts or privileges made available to Hotham and Falls Creek Super Pass holders at Hotham and Falls Creek other than lift ticket benefits.
 4. Super Pass holders must agree to and abide by the terms and conditions of use of each resort when using the applicable resort's facilities.
 5. To gain access to Perisher lifts, Hotham and Falls Creek Super Pass holders must present their Super Pass at a Perisher Ticket Office to be issued with a one day lift ticket on each day they wish to use the lifts.
 6. To gain access to Hotham or Falls Creek lifts, Perisher Super Pass holders must present their Super Pass at a Hotham or Falls Creek Ticket Office to be issued with a one day lift ticket on each day they wish to use the lifts.
 7. Hotham and Falls Creek Super Pass holders are eligible to receive one only one day lift ticket at Perisher per day.
 8. Perisher Super Pass holders are eligible to receive one only one day lift ticket at Hotham or Falls Creek per day.
 9. A Super Pass holder that has been issued with a one day lift ticket must have their Super Pass and issued one day lift ticket on their person at all times when using any lift, and must present their Super Pass and lift ticket for verification if requested to by an authorised officer of the resort in order to access any lift.
 10. Any breach of the Super Pass Terms and Conditions of Use or Terms and Conditions of Perisher, Hotham or Falls Creek could result in confiscation of the Super Pass and lift ticket and may invoke police action.
 11. Super Pass holders will be issued with an Adult, Over 65 or Student lift ticket as outlined above consistent with Adult, Over 65 or Student designation of their Super Pass.
 12. Super Pass does not provide access to Falls Creek Night Skiing.

IF YOU BREACH ANY OF THE CONDITIONS OF THIS SEASON PASS WE MAY REQUIRE YOU TO FORFEIT THE SEASON PASS AND YOU WILL LOSE ALL PRIVILEGES ASSOCIATED WITH THIS SEASON PASS.

PASS INSURANCE

The Pass Insurance provides you with the reassurance of a partial refund as outlined below.

1. **Without purchasing the pass insurance, season passes are NOT refundable or creditable under any circumstances.**
2. The Pass Insurance is only available when purchased with your season pass, and is valid for season 2011 only.
3. Where the Pass Insurance is taken Mount Hotham Skiing Company (MHSC) and Falls Creek Ski Lifts (FCSL) will refund a percentage of the cost of your season pass if you suffer injury/sickness which prevents you from further participating in skiing or snowboarding.
4. Mount Hotham Skiing Company/Falls Creek Ski Lifts will refund the cost of your season pass if you are transferred interstate by your employer; provided that the date of transfer is at least 30 days after the purchase of your season pass (Victorian residents only).
5. The Pass Insurance fee is not refundable under any circumstances.
6. The Pass Insurance does not cover pre existing injuries or conditions.
7. To request a refund, you must supply MHSC or FCSL with a written request within 10 days of injury, including a covering letter of explanation, your 2011 season pass and medical certificate stating the cause & date of injury and prognosis. Refunds will be calculated from the day we receive your request.
8. Pass Insurance claims will not be accepted after 10 August 2011.
9. All refunds are subject to Management's approval and discretion.
10. MHSC and/or FCSL interpretation of the above conditions is final.

PASS INSURANCE REFUND SCHEDULE:

For injury or sickness which prevents you from further participating in skiing or snowboarding during season 2010 your refund equates to;
